## **APPENDIX A: Mapping of related work**

## Overview

As part of the scoping phase for the Housing Issues & Priorities during COVID-19 project, commissioned by the London Public Health System Resilience Leadership Group, a rapid mapping exercise was undertaken to capture related work that was underway at national, regional and local levels.

The purpose of this paper is to share the results of this rapid mapping. It summarises some key resources that are available and outlines what work is currently underway under two categories: research and analysis; and practice and support. It is not intended to be a comprehensive map of all related work, but a snapshot of initiatives relevant to the project and its key stakeholders.

The mapping exercise was undertaken from June to August 2020 and will not be updated. With, projects changing so rapidly in response to the pandemic this map only reflects the position at the time the mapping was undertaken.
